# Recent procedure changes(1)



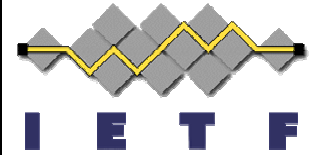
- Draft-alvestrand-ietf-mission
  - Probably low impact now – “stating the obvious”
  - No comments in Last Call (people tired?)
  - Approved as BCP (announced Saturday!)

# Recent procedure changes(2)



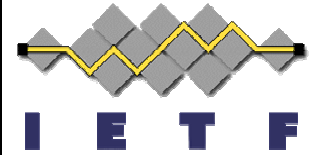
- Draft-klensin-july14
  - Allows for a lightweight procedure for procedure changes
  - Passed as BCP by the IESG
  - "Almost" used for draft-hardie-alt-consensus
  - Unclear issue: When does the ISOC BoT approve changes to the standards process?

# Recent procedure changes(3)



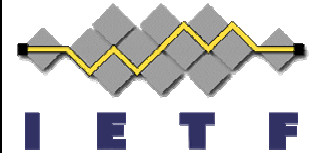
- Draft-wasserman-rfc2418-ml-update
  - Allows more WG chair control of mailing list
  - Passed as BCP by the IESG
  - So far, not used
- Draft-hardie-alt-consensus
  - Mechanisms that can be used for consensus finding
  - Passed as Experimental by the IESG
  - It will be interesting to see if it is used

# Recent procedure changes(4)

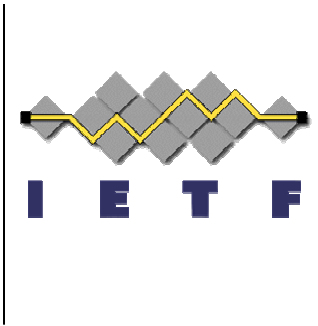


- Draft-ymbk-downref
  - Clarifying when std-track can refer to info
  - Emphasizes sending info in Last Call
  - Was hung up on definition of "normative"
  - Approved as BCP by IESG
- Draft-iesg-vendor-extensions
  - Slow-moving draft on extension mechanisms
  - Not an easy area to make clear
  - Still under discussion

# Recent procedure changes(5)



- IESG: RFC Editor document handling
  - Draft-iesg-rfced-documents
  - Technical objections to RFC Editor as comments
  - Passed as BCP by the IESG
  - In use (in draft form) since April
  - Has reduced backlog of RFC-Ed documents & IESG heartburn significantly
- IESG: Red team/Blue team
  - Half the IESG (one per area) reviewing info/experimental documents via WG or AD
  - Results inconclusive – no disasters, not that much improvement
  - Experiment may continue – not decided yet



# Looking forward

- ICAR – early review – separate WG
  - Ready to start an experiment
- NEWTRK – procedure changes – separate WG
  - Some relatively short-term suggestions being discussed (moving to historic)
- Possible formalizations of informal process
  - Id-checklist and id-guidelines
  - Advice on IANA sections and keywords?
  - Draft-ymbk-
