


d) RFC Series and IANA: RFC Model

- draft-iab-rfc-editor-model-v2-00 appeared shortly after the deadline
- IAB intends to assess whether the proposed modifications to the model are supported by the community
- Ambitious schedule meet the March deadline.
 - We are aware of the need for contingency

 We will have a 'high level meeting' between IETF leadership and members on of the the ECs DG INFSO, December 14


