



Q2 Did you participate in an IETF meeting in either 2018 or 2019 (IETF 101 to IETF 106)?






Q3 Which of the following best describes your participation in IETF meetings?












Q6 Did you participate in IETF 108?



Q7 How much did each of the following affect your decision not to participate?

















