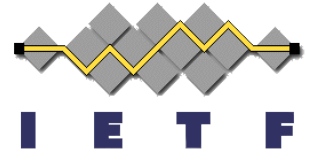
- When starting a presentation you **MUST** say if:

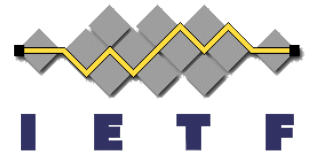

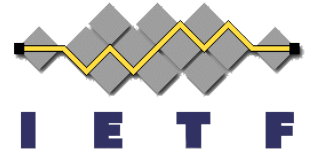
